





COMPETITION RULES OF NATIONAL COMPETITION for the best SHORT FILM filmed with mobile phone that promotes natural and landscape values of AQUATIC AND WETLAND ECOSYSTEMS connected with the area covered by the project LIFE13 NAT/PL/000018 entitled OSTOJA I POBRZEŻE SŁOWIŃSKIE

I. ORGANIZER:

II. OBJECTIVES:

Today, almost everyone has a mobile phone or tablet, for this reason we encourage all users of **MOBILE DEVICES** to use them actively and to have fun on nature paths and tourist trails of the Slowinski National Park.

- 1. Inspiring the public to connect with the nature of Slowinski National Park.
- 2. Sensitizaton to the beauty of nature, for the need of its protection.

III. PARTICIPATION:

- 1. It is a NATIONWIDE Competition and it is designed for amateurs of short films IN THREE AGE GROUPS:
- 1) I primary school children;
- 2) II students from middle and upper secondary schools;

- 3) III adults (over 19).
- An essencial requirement for the participation in the competition is, among others, consent to the processing of personal data included in the application form in accordance with art. 23, act.
 point 1 of the Act of 29 August 1997 on the Protection of Personal Data (Journal of Laws 2015, position 2135 as amended) (declaration, attachment no. 2).
- 3. In case of minors, participation in the competition is possible if parental or legal guardian consent has been provided (parental consent, attachment no. 3).
- 4. Providing personal information in the application form (application form, attachment no. 1) is voluntary, but it is necessary for carrying out the Competition.
- 5. The controller of personal data submitted by the Participant of the Competition in the application form is Slowinski National Park which processes personal data of the Participants in accordance with art. 23, act. 1, point 1 of the Act of 29 August 1997 on the Protection of Personal Data (Journal of Laws 2015, position 2135 as amended)
- 6. Personal data will be processed only for the purposes of the Competition organized by the Slowinski National Park.
- 7. In the cases and under the terms of the Act of 29 August 1997 on the Protection of Personal Data (Journal of Laws 2015, position 2135 as amended) the Participant of the Competition has the right to amend, update, or correct personal details, temporarily or permanently suspend or erase them, if they are incomplete, outdated, untrue or collected in violation of the law or are no longer required for the purpose for which they have been collected, and the right to make a written request to cease processing his/her personal data.
- 8. The Organizer of the Competition reserves the right to publish name and surname of the author of the competition work, among others, on the website of the SNP, on the website of the project LIFE13 NAT/PL/000018, on Facebook page of the SNP, for information and promotion purposes, and in information and promotion materials of the SNP.

IV. THEME:

 Natural and landscape values of AQUATIC AND WETLAND ECOSYSTEMS connected with the area under the project LIFE13 NAT/PL/000018, including LUPAWA RIVER, POLDERS ON THE EASTERN SHORE OF LAKE GARDNO, WATER PLANTS









INCLUDING WATER-CROWFOOT, BIRDS RELATED TO THE AQUATIC AND WETLAND ECOSYSTEMS, LAKE GARDNO.

- The Organizer does not allow dissemination of the IMAGES OF PEOPLE shown in short films, WITHOUT THEIR CONSENT. In accordance with art. 81 act. 1 of the Act of 4 February 1994 (Journal of Laws. No. 90, position 631) dissemination of image requires the consent of a person depicted in it.
- 3. The aforementioned permission is not required, among others, from the person who constitutes only a detail of such a whole as gathering, landscape, public event.

V. DATES:

- 1. Date of the announcement of the Competition: 25 April 2016
- 2. Submission deadline: 30 September 2016
- 3. Proceedings of the evaluation committee: 3 7 October 2016
- 4. Announcement of the Competition results: 10 October 2016

VI. QUANTITY:

One Participant of the Competition in his age category may submit a maximum of 3 short films.

VII. TECHNIQUE:

- 1. Duration of a film: minimum 2 minutes, maximum 6 minutes.
- 2. The film must contain opening and closing credits, including the title of the film.
- 3. Entries must be submitted on a CD or DVD in a format that can be played by, among others, a standalone DVD / DivX player (DVD or VCD, formats like .avi and .mp4 are also acceptable).
- 4. The discs should be labelled (author's name and surname, title of the film) and packed in rigid boxes with label (author's name and surname, title of the film).
- 5. There may be several films stored on a single disc (one Participant of the Competition in his age category may submit a maximum of 3 short films).

- 6. Along with submitted works the author should attach:
- 1) application form (attachment no. 1)
- declaration regarding, among others, personal data, copyrights, granting licence (attachment no. 2)
- 3) parental/legal guardian consent for the participation of their child in the competition (attachment no. 3).

VIII. WORKS SHOULD BE SENT TO:

Słowiński Park Narodowy, ul. Bohaterów Warszawy 1A, 76-214 Smołdzino in an envelope with an annotation "LIFE13 NAT/PL/000018 - Konkurs" **by 30 September 2016** (the postmark date is determinative). Submitting works for the competition will be considered as the acknowledgment and acceptance of these Competition Rules.

IX. SETTLEMENT OF THE COMPETITION:

- 1. The competition works will be evaluated by the four-person Jury appointed by the Organizer.
- 2. The Jury meeting will take place on **3 7 October 2016**.
- 3. The Jury will evaluate the submitted works and award prizes.
- 4. Works that do not meet the requirements will be rejected. The decisions of the Jury cannot be appealed.
- 5. **In each age category four prizes will be awarded** (I, II i III place, and distinction). There will be awarded for the 1st place tablet, 2nd place binoculars, 3rd place rucksack, distinction sleeping bag.
- 6. In accordance with art. 21 act. 1 point 68 of the Personal Income Tax Act, the abovementioned prizes are exempt from income tax (one-time value the prizes does not exceed 760 PLN)
- 7. The prizes will be sent via telecommunication operators. The Organizer is not responsible for delays and irregularities in the operation of telecommunication operators.
